

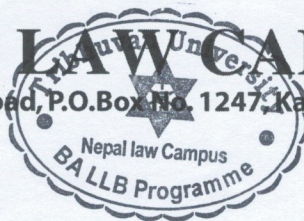

Call for Paper

Nepal Journal of legal Studies (ISSN: 2542-2790) is a student-run peer reviewed journal published annually by Nepal Law Campus, Tribhuvan University. After successful publication of the second volume, the journal is now accepting original and unpublished submissions for its upcoming volume (Vol. 3, Issue 1, Number 1&2, Year 2022-23), which is scheduled to be released by early 2023.

Journal invites submissions from early career and established scholars, professors, members of bench and bureaucracy, practitioners and postgraduate students with the objective that plurality of experiences and perspectives is represented. Submissions from undergraduate students are also highly encouraged.

The third volume is not thematic in nature and accepts submissions on any legal issues concerned with Nepal or pertinent global legal issue. The submissions shall be reviewed by double blind peer review method.

Submission Guidelines:

- Font: Times New Roman, 12 pt.
- Line Spacing: 1.5 pt (within lines) and 2 pt (within paragraphs); footnotes shall be single line spaced with 2 pt in between two footnotes
- Format: Manuscripts should be submitted in Microsoft Word (.doc) format
- Citation Style: Bluebook Style of Citation (21st Edition), Footnote Citation
- Word Length: Standard word length is around 8,000 words for articles. It is expected that the submitted articles shall be of at least 4,500 words. However, considering the originality and significance of the paper, the journal may accept articles of any word length.
- Submissions: All submissions must be sent via email to njls@nlc.edu.np. The deadline for submission of all articles is June 25th, 2022.
- Co-authorship is allowed within two authors.
- The authors must accompany a Cover Letter with their submission disclosing their name(s), institutional affiliation, contact details, title of paper along with a disclosure that the content is original, not under consideration for publication anywhere, and it does not violate copyright of others.

Editorial Policy

Nepal Journal of legal Studies (ISSN: 2542-2790) is a student-run peer reviewed journal published annually by Nepal Law Campus, Tribhuvan University. After successful publication of the second volume, the journal is now accepting original and unpublished submissions for its upcoming volume (Vol. 3, 2022-23), which is scheduled to be released by early 2023.

The article received via any medium for the Journal shall undergo following procedure:

1. **Preliminary Review:** Once the author sends the manuscript (within the deadline) to the editorial board, the manuscript is subjected to preliminary review. In this phase, the members of the board shall review the manuscript to check if the article fits within the scope and requirement of the Journal or not. This process might take around 2 months.
2. **Double-blind peer Review:** After the board is satisfied with the preliminary review, the manuscript is subjected to the double-blind peer review. In the process, the manuscript is sent to more than 2 peer reviewers. It might take around 4 weeks.
3. **Reply to author:** Depending upon the reviewer's comment and suggestions the board shall communicate with the respective author. It might take around 2 weeks. Based on the recommendation and suggestions, the manuscript may be completely rejected, accepted or suggested for revisions. In case of acceptance and complete rejection, the author is communicated the same. In case of revisions, the author is forwarded the compiled suggestion from the reviewers.
4. **Revisiting the article:** The author, after receiving the manuscripts and suggestions, is required to make the respective amendment and send it back to the editorial board of the journal.
5. **Finalizing the manuscript:** Once the editor finally approves the manuscript, the author is communicated to make final confirmation on the correct citation format. Also, the author shall be asked to provide the abstract for the manuscript. After the finalisation of the citation and abstract, the manuscript shall be sent to the publishing unit for the incorporation in the journal.

Few notes:

1. Reviewers are anonymous to each other and also, the anonymity of the manuscript shall be maintained.
2. The members of the editorial board shall not change the content of the manuscript.
3. The members of the editorial boards are not the peer reviewers.
